



## **2023 KdVS PATIENT ADVOCACY SUMMIT CHILDCARE FAQs**

### **Why is childcare being offered for the summit?**

Presentations on July 20th and 21st are welcome to adults only so that all presenters and attendees are able to devote full attention to the information being discussed. Babies that can be worn are permitted. Families are welcome to make their own childcare arrangements with family members/family support during the summit. No children under 18 are permitted in the sessions. Please plan accordingly.

### **Who can participate in childcare?**

The childcare service is available to all individuals who may require care. Individuals of all abilities ages 0-17 are welcome including KDVS individuals, individuals with different disabilities, and typically developing individuals. This service is also available to individuals aged 18+ that may require some additional supervision while caregivers are attending sessions.

### **Where will the childcare take place?**

Childcare will be held in the Palaini Conference rooms on the second floor of the Renaissance Orlando SeaWorld Resort. These conference rooms are down the hall from the breakout sessions, or up one flight of stairs from the main ballroom.

### **When are the time slots that childcare is being offered?**

Childcare will be available on Thursday, July 20th from 8:00-12:00PM and 1:00-5:00PM. Childcare will be available on Friday, July 21st from 9:00-12:00PM and 1:00-5:00PM.

**If I choose to send my child(ren) to childcare, can I select slots or do I need to commit to full days?**

You will be able to choose which slots you would like to send your child(ren) to based on your interest in presenters/sessions.

**How do I sign up/set up childcare?**

All childcare registration is available through summit registration and through corporate kids events. The corporate kids event registration form can be found here. Corporate Kids Events will provide families with registration forms which accommodate all circumstances, including emergency consent, special childcare needs, and photography waivers. **What about childcare tickets?**

Your child must have a ticket for each session of childcare offered. If you plan to utilize all four sessions (Thursday morning & afternoon, Friday morning & afternoon) you must purchase four tickets. Only individuals who have a ticket AND who have completed the Corporate Kids Registration form and emailed their PDF to Katie, will be able to participate in Childcare.

**If I need to change my childcare reservation, what is the latest date I can do so without being charged?**

You can change your childcare reservation until June 18, 2023. No refunds, changes, cancellations, or additions will occur after this date. Waitlist childcare tickets are available, and if there is enough interest, we are able to open more childcare slots which may reduce the cost.. We will contact you if a spot opens up and for payment.

**Who are the individuals supervising our children when we sign up for childcare services?**

Corporate Kids Events (CKE) program managers are experienced childcare professionals, certified in CPR and First Aid, and cleared to work with children. These individuals have provided copies of certifications, clearance and detailed resumes, they have been through interviews, extensive reference checks and security background checks.

**How are the staff prepared to watch our children?**

All staff attend a special training and orientation prior to the KDVS Summit where staff are briefed on planned schedule of activities, children attending, the overall conference group, and emergency procedures specific to the event.

### **What are the staff to child ratios?**

### **What will my child(ren) do while being supervised by Corporate Kids Event?**

CKE will provide a schedule of events and activities closer to the summit. The published schedule of activities allows parents to feel comfortable with CKE as their kids' temporary guardians, thus ensuring a high turnout, strong participation and overall satisfaction. Some potential themed activities include Super Space Odyssey, Pirate Adventure, Super Spectacular Hero Day, Beach Party Bonanza, and Art Extravaganza.

### **How is safety enforced with Corporate Kids Event?**

Before, during and after the event, SAFETY is CKE's primary concern. The safety program includes the use of ID bracelets, secure sign-in and sign-out procedures, and a digital photo security system.
